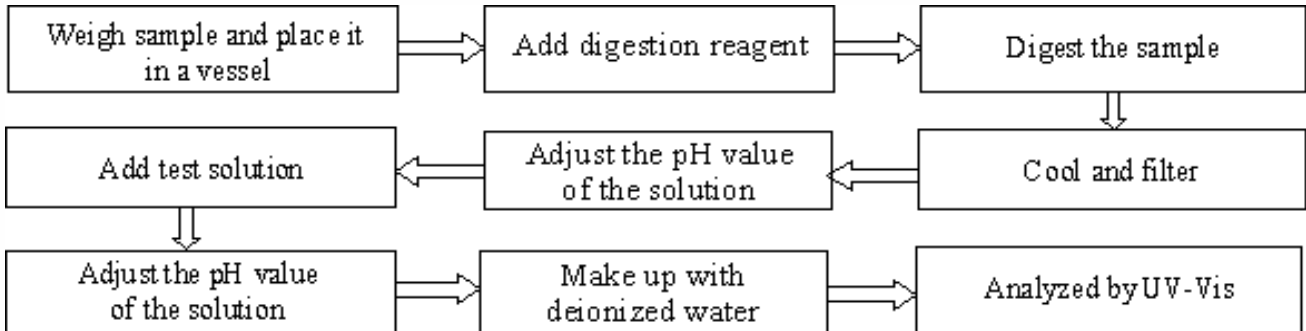

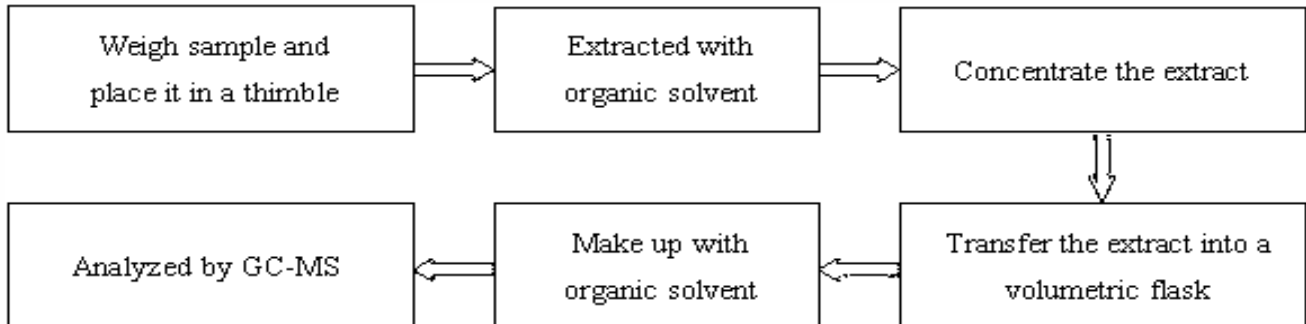
2. Mercury(Hg)

4. Polybrominated Biphenyls(PBBs), Polybrominated Diphenyl Ethers (PBDEs)

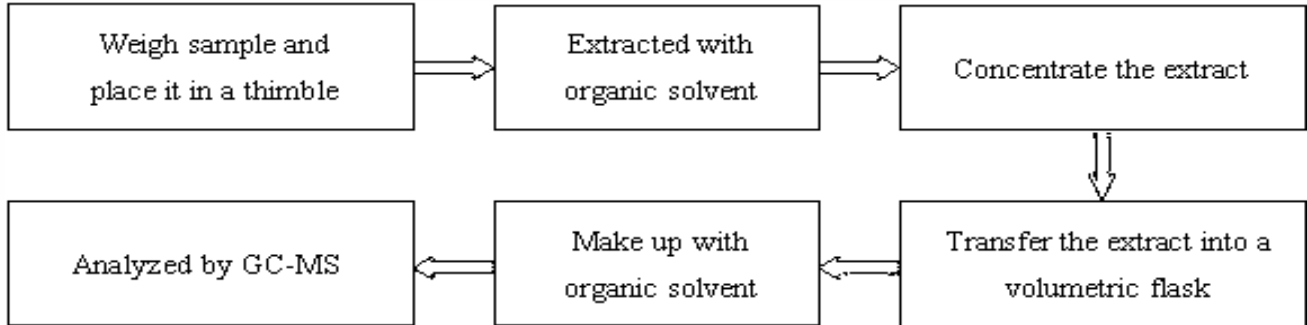
